EXECUTIVE DIRECTOR CEO

- Operations Review Have asked Chris Miller, COO, to conduct an admin/operations review of Pasadena Media. Are we structured the right way? Are we fulfilling our obligations to the community through the services we provide? Are we making an overall relevance in the community that we serve? Review to be complete by the end of the year; details forthcoming at the beginning of 2020.
- Ribbon-cutting ceremony for the grand opening of Studio B/Podcasting took place on November 22 with the community and board members present.
 Very strong positive reactions from producers regarding this podcasting service that we offer.
- Met with Ken Chawkins, PCAC Board Vice President, and Mike Alvarez, Professor of Political Science at Caltech, along with Kenneth Hargreaves, Asst. VP of Strategy Implementation and External Relations Officer and Shayna Chabner McKinney, Chief Communications Officer - Office of the Strategic Communications, to discuss our election coverage for 2020.
- Successfully taped and aired IMPACT Pasadena with Congresswoman Judy Chu of California's 27th congressional district. Interview went well, Congresswoman Chu was pleased with our facility and staff.
- Met with PCAC Board President Sally Howell and COO Chris Miller to discuss updates and current projects at Pasadena Media.
- Attended the SoCalGas Community Advisory Council meeting.
- Attended various Rotary meetings Rotary Board & Rotary Program Committee

<u>OPERATIONS</u>

- The Alliance for Community Media along with municipal allies across the U.S. supported a motion to stay the FCC's Third Report and Order in Federal Court last week. The FCC on Friday won its argument for the case to be moved to the 6th Circuit Appeals Court.
- All equipment is now permanently in place in Studio B. Several community members have utilized the studio to create their first episodes, which will be scheduled on both Arroyo and our "Listen" page shortly.
- An intermittent issue on Charter's end caused three of the PEG channels to be unavailable to cable boxes inside our building. Our engineer Joe has taken this opportunity to explore again other delivery options to Charter.

Operations Report - November 2019

- Threat to Franchise Fees & PEG: FCC Proposed Rulemaking, MB Docket No. 05-311 UPDATE The Alliance for Community Media along with municipal allies across the US supported a motion to stay the FCC's Third Report and Order in Federal Court last week. The stay motion says the FCC is wrong on the law when it tries to rewrite the Cable Act something courts found when they reviewed the agencies earlier actions on the matter and the agency will cause irreparable harm if the Order is allowed to proceed. The FCC on Friday won its argument for the case to be moved to the circuit which heard Montgomery County et al vs FCC. The 6th Circuit Appeals Court will now consider the motion and the following legal challenge.
- New Studio B: Completed UPDATE - A more powerful desktop computer is replacing an old laptop we've been using. With that change, all equipment is permanently in place. Several community members have utilized the studio to create their first episodes. Member programming on both Arroyo and our "Listen" page will commence in the next two weeks.
- Charter Signals Issue: In Progress During the first two weeks of November, three of the four PEG channels have together been black intermittently in our suite on Charter cable boxes - KPAS, Arroyo and KLRN. As the fourth channel is delivered to Charter from the same origination site as two of the others, we were able to rule out our equipment immediately. As the channels continued to be available in other parts of Pasadena, we are again pursuing localized cabling issues to the office building with Charter technicians. Our engineer Joe has taken this opportunity to explore again other delivery options to Charter. We will keep you informed as the situation develops.
- Wireless Mics Frequency Issues: Completed
 All wireless microphones in the U.S. utilizing frequencies between 617 and 698 MHz
 are required to cease operation no later than July 13, 2020. However, over the past
 several months we have started to encounter interference with several of our wireless
 mics as cellular operators roll out expanded service in our region. We have
 discontinued use of affected mics and have included replacement in our PEG
 equipment request tonight.
