- Pasadena Media recently received a check donation of \$500 from SoCalGas courtesy of George's participation with their Community Advisory Committee (CAC) meetings.
- Pasadena Media covered and televised Robert Gorski's Memorial service held in the courtyard at City Hall.
- Senator Feinstein has joined Congressman Schiff as a co-sponsor of the Protecting Community Television Act. We must keep reaching out to Congresswoman Chu and Senator Harris to let them know how invaluable we are, especially at a time like this.

- The normal preliminary budget meeting with City Staff was cancelled this year. Finance Dept. staff has reported that the recommended budget packet being prepared for City Council includes the proposed PCAC budget as the Board approved last month.

Operations Report - March 2020

- UPDATE Threat to Franchise Fees & PEG: Protecting Community Television Act Companion Senate and House bills would deflate the FCC's notion that "in-kind" services are actually fees being charged to cable companies. And it would stop cable companies from charging back hidden fees against their franchise obligations. Senator Feinstein has signed on to co-sponsor S.3218, joining Congressman Schiff (an original co-sponsor of HR5659) as representatives that are responding to our concerns. Congresswoman Chu and Senator Harris have been unresponsive. While it is likely harder than before to reach these representatives, it is also the perfect time to let them know how invaluable we are at a time like this. I urge all of our stakeholders to keep reaching out to them.
- Issue Delivering Arroyo to Charter: Completed The issue that occurred twice on Sunday mornings in which Arroyo video has frozen on a frame while audio continues has not reappeared so cannot determine a cause. We will continue to monitor.
- Assisting Assemblymember Chris Holden with Letter to Charter: Completed Please find Assemblymember Holden's letter to Charter regarding the lack of offering PEG channels in HD on the next page.
- PEG Equipment Installation: Ongoing The TelVue content distribution system arrived just before we implemented work-from-home protocols for the entire staff. Given the numerous advantages to the system, especially in a scenario where people are home all the time, we are fast-tracking the installation as much as we can. Once we receive hard drives next week, content can be migrated. After that process is complete, in theory, we can populate schedules and switch systems. The HP computers have also arrived, but have only been unboxed to verify that they are operable.
- City Council Meeting Support: Ongoing
 - Our staff supported the delivery of the March 17 City Council meeting as usual. While only two Councilmembers were present in the Chamber, other members participated via the phone conference bridge that is a part of the room's normal technical amenities. After the Safer At Home order, we worked with DoIT and City Clerk staff to develop a way to conduct meetings with all Councilmembers participating remotely while ensuring public participation. The March 30 meeting was successfully held using Zoom after numerous adjustments to Chamber technology including insertion of Chamber video as a Zoom user, audio routing, and closed captioning.
- FY 2021 Budget: Ongoing

The normal preliminary meetings between Department / Operating Company directors, the City Manager and Finance Department staff were canceled this year. Finance staff has reported that the recommended budget packet being prepared for City Council includes the proposed PCAC budget as the Board of Directors approved last month.

Dear Mr. Hidalgo,

I write today with concerns about Charter Communication's resistance to providing Public, Education and Governmental (PEG) channels in high definition (HD) for Californians. With HD television now ubiquitous in California homes, the time has come to provide this valuable local content to your customers in a manner they are accustomed to using. My constituents should not have to choose between prevailing quality images and truly local information.

Per the Digital Infrastructure and Video Competition Act of 2006 (DIVCA), PEG channels must be available on the lowest-cost tier. Currently, Charter's lowest-cost tier is limited to standard definition. However, there is no language in DIVCA or any other law stating that the channels cannot be made available in higher quality on other tiers. PEG facilities across the state have been producing content in HD for many years now and must downgrade their signals for distribution via Charter's networks. My sense is that this extra processing is unnecessary and costly for both Charter and PEG facilities.

The decision to withhold local content in its original HD format signals an unwillingness on Charter's part to meet community needs. This inaction undermines the spirit of both DIVCA and the 1984 Cable Act. PEG stations connect Californians with each other, their local governments, and their schools by bringing local content, news, municipal government meetings and proceedings, and emergency alerts directly to my constituents. I urge Charter to consider my concerns and make certain that your actions do not threaten the visibility of PEG channels.

Agenda Report Operational Update During COVID-19 Pandemic April 7, 2020

Recommendation:

The following report is for information only. No action is required.

Executive Summary:

The health and well-being of our community is our top priority. In addition, our organization is uniquely positioned to assist Pasadenans during an extended emergency. This report lists the various steps that staff has taken during the past few weeks related to the COVID-19 pandemic crisis.

Background:

On March 13, the facility was closed to the public indefinitely. All classes, studio productions, editing reservations and equipment checkouts are cancelled until further notice. Community programming can continue to be submitted online.

On March 16, staff began working from home with some coming into the studio as necessary for technical operations and administrative support. Staff has been provided with protective masks, gloves, disinfecting spray and wipes for all in-studio or field work assignments. We continue to have daily admin and weekly all-staff web conferences. Hours of operations remain Monday thru Friday from 10 am to 6 pm, with staff available to assist the community via phone and email. Operations staff implemented remote login procedures for critical machines. Administrative duties/operations continue in areas such as accounts payable, admin support, payroll and benefits.

Successfully executed and televised the first City Council meeting conducted via a Zoom web conference. All Councilmembers participated and City Manager Steve Mermell, City Clerk Mark Jomsky and City Attorney Michelle Bagneris were in the Council Chambers. Pasadena was one of the first cities in the region to hold their City Council meeting virtually. We have received many compliments and questions regarding how we accomplished this task.

Since March 20, staff has been working with PIO Lisa Derderian and Mayor Tornek to record public service announcements regarding the COVID-19 crisis in the studio. These PSAs are shared via the City of Pasadena and Pasadena Media's social media platforms, as well as the KPAS bulletin board.

Staff has supported captioning and subtitling for videos created by the City Manager and the Public Health Department Director.

Staff has implemented 24/7 crawls on KPAS, Arroyo and PCCtv that update the community on important announcements from the City, County, State, and PCC.

Staff has been working with the City of Pasadena's Parks, Recreation and Community Services Department to create a virtual exercise series for the community to stay active called *Rec Connect*.

Staff has been producing additional informative content for the KPAS and Arroyo bulletin boards, including PSAs focused on discouraging hoarding, directing the community to the City of Pasadena's website and social media platforms, and information about the temporary parking policy.

Staff has augmented KPAS and Arroyo bulletin boards with numerous PSAs from CDC, CDPH, AdCouncil, and others.

Pasadena Media News has shifted focus to local daily stories related to the COVID-19 pandemic.

The *NewsRap* local news brief segment has also shifted focus to stories related to COVID-19.

Staff is developing a call-in show to air on Arroyo with goals of aiding community communication and wellness.

Staff is soliciting Safer-At-Home video content from the community to be packaged for Arroyo.

Staff is creating various tutorials to ensure our community continues to have the tools it needs to effectively create and communicate including videos on how to submit shows and editing tips.

Admin has provided an extension on our accounts receivable for those who are financially impacted by COVID-19.

Operations staff are fast-tracking the TelVue content distribution installation as much as possible to take advantage of the new features as soon as possible.
