4. EXECUTIVE DIRECTOR REPORT (Falardeau & Miller)

- Pasadena Media studios, with few exceptions, remain closed due to pandemic protocol
- A limited number of shows were produced during the past several months, including:
 - State of the City
 - Police Reform
 - Pasadena Media News Updates
 - o Innovate Pasadena Presents
 - Body-Mind-Spirit
- PCAC budget submitted to City Council with no significant revisions required to date
- Key staff was lost to various opportunities, including Bobbie Ferguson (Head of Production) and Hannah Ramirez. Alex Gomez was recently hired as a Production Technician
- An upcoming Arroyo Live show will highlight Asian American Pacific Islander (AAPI) voices in Pasadena, with panelists including Councilmember Gene Masuda, Public Defender Mercedes Cook, Recording Artist Keira Kang, Faith and Community Empowerment Founder Hyepin Im, and Asian Pacific American Bar Association of Los Angeles President Arnold Lee
- There is the possibility for a "soft open" of the Pasadena Media studios this summer, still TBD
- An episode of Innovate Pasadena Presents featuring NASA engineer Johanna Lucht and hosted by Ka-Yun Lau won a 2021 WAVE Award from the Alliance for Community Media Western Region in the category of Underserved Voices – Professional Division
- Committee members are strongly encouraged to support the "Protecting Community Television Act"

Pasadena Community Access Corporation, Citizens Advisory Committee, Access Subcommittee July 22, 2021

Attendees: Phil Hopkins, Diana Peterson-More, Martin Sweeney

Meeting Notes:

- Phil welcomed Diana and Marty to the subcommittee and to this meeting.
- The charter of the Access subcommittee is to review and recommend to the CAC, in conjunction with staff, potential technologies and techniques to facilitate "access for all" related to video and Web content generated or presented by Pasadena Media.
- Marty outlined a recent video call he and Phil participated in with Chris Miller (COO of Pasadena Media) regarding open and closed captioning. Background: Pasadena Media uses a combination of technologies for captioning, including –
 - Free captioning transcripts provided by YouTube that are downloaded and formatted by staff using Subtitle Edit (https://nikse.dk/subtitleedit). This technique represents the bulk of the captioning provided by Pasadena Media. It is reliant on Google continuing to provide automated captioning for YouTube.
 - A server-based solution for KPAS and a few Arroyo Channel shows that provides in-house closed captioning for live cablecasts and video livestreams. This technology works well, but currently has active storage for <20 shows.
 - Open captioning is generally not used because the video quality of both Charter/Spectrum and ATT's U-verse PEG channels is low resolution. The cablecast resolution issue is unlikely to change in the near term for a variety of reasons.
- Based upon this background, the recommendations from the subcommittee would naturally fall within the following scope:
 - Video captioning technologies and techniques, both for live and recorded shows;
 - New Web and channel content regarding preferential access methods for Pasadena residents;
 - Ongoing Web site ADA compliance.
- Possible solutions for further study include
 - Development of a Web page on the Pasadena Media site regarding preferred access methods for the community (e.g., an infographic documenting which local PEG media are high and low resolution and how that impacts access for all);

- Recommending additional server and/or captioning subscription resources to perform live automated captioning in-house;
- Development of PSAs and/or interstitials regarding Pasadena Media's commitment to access for all and connecting audiences back to the new access page on the Web site;
- A request for the Pasadena's Accessibility and Disability Commission to survey the community regarding preferred access methods for video content (assigned to Marty for follow-up);
- A request for the Commission to also perform an informal ADA audit of the Pasadena Media Web site (assigned to Marty for follow-up);
- Deployment of WordPress plug-ins for the Pasadena Media Web site to monitor content accessibility dynamically (assigned to Phil for follow-up with Chris);
- Lead a focus group of <10 community members selected in cooperation with the Accessibility and Disability Commission (assigned to Diana for follow-up);
- Focus on "Pasadena values access for all" rather than "numbers of impacted constituents in my council district" throughout all approaches.
