## (DRAFT) Pasadena Media CAC Advisory: Community Media Center Dual Enrollment & Workforce Development Alignment

## Goals

\* Offer an *aligned* television production training pathway, starting in local public secondary education, utilizing local public higher education oversight, and incorporating local community media center production expertise.

\* Build on existing processes to implement options for workforce development pathways leading to career opportunities in television and professional video production.

\* Everybody wins.

# Focus

\* Provide entry points for broader community engagement with existing television training resources.

\* Training curriculum coordination across PUSD, PCC and Pasadena Media, aligned with PCC dual enrollment (college credit) and community extension (non-credit) processes for career and technical education.

## **High-Level Issues**

\* Identify PCC certified instructor(s) for dual enrollment component.

\* Integration of pathways with attendance and grading systems.

\* Availability of funding through youth training sources and the PCC Foundation.

 $\ensuremath{\ast}$  Identification of internship opportunities, internally and externally (industry partnerships).

## **Potential Success Measures**

✤ Enrollment in aligned pathways program.

\* Post-internship career placements, either internally (e.g., Pasadena Media) or externally (industry partnerships).

\* New television programming starts utilizing pathway participants, and sustaining programming with pathway participants over time.
