ANNOUNCEMENTS - Aaron Wheeler, Supervisor of Member Services, has applied for grant submission with the Tournament of Roses. TOR has accepted our application; details forthcoming.

Chris Miller, COO and Bobbie Ferguson, Production Supervisor, have submitted 5 programs to the ACM West WAVE Awards. Deadline for submission is January 1, 2017.

Aaron Wheeler has commenced discussions with Jericho Road, a non-profit resource for marketing, communications and fundraising; details forthcoming.

KEY ACHIEVEMENTS:

Member Relations/Outreach

- Aaron Wheeler reports that Pasadena Media currently has over 50 active producers with a potential of up to 60 new additional producers that are currently under review.
- Current total users of Pasadena Media facilities and services for 2016 is 177.
- The total number of orientation participants for 2016 is 163.
- List of volunteers for PM for 2016 is 108.
- Aaron Wheeler is in the process of advising First Tee of Pasadena on developing a program to air on the Arroyo Channel.
- Pasadena Media Staff met with Chief Bertral Washington, Fire Chief City of Pasadena, to discuss future partnerships for KPAS and the Arroyo Channel.

Facilities

- Have identified space planner/architect to define our reallocation of space from the 4th floor to the 1st floor; details forthcoming.
- Have identified a local real estate broker to address our leasing requirements for our existing space.
- Chris Miller continues to work with National Hispanic Media Coalition for the installation of an antenna on Pasadena Office Tower's roof with no immediate need for radio studio space at this time; details forthcoming.

Productions

 Pasadena Media provided live coverage of the City of Pasadena's Veterans Day Event.

- ED/CEO met with Andre Coleman to discuss future programming.
- Aaron Wheeler has brought back Peter Dills, Food Critic, to the Arroyo Channel.
- Roberta Martinez is in development for returning to Pasadena Media to air her series of Latino community-based programs.
- Pasadena Media contacted local non-profit organizations and offered free PSA Video services.
- Pasadena Media assisted KPAS in promoting the anti-smoking public health campaign called the "Pasadena REACH Project".

Personnel

- Liza Rodriguez was hired as our new Office Administrator and Assistant to the Executive Director CEO.
- ED/CEO and COO are working with retirement plan consultants for employee benefits; details forthcoming.

Financial

- Pasadena Media has received additional \$500 in donations.
- Chris Miller has made the formal request for Quarterly payments from the City of Pasadena.

Board

- ED/CEO met with Board Member Grant McComb to discuss PCAC advisory board potential candidates.
- Gail Schaper-Gordon has asked that each Channel Manager for Pasadena Media make a Quarterly Report on the status of their individual operations.

Operations Report - November 2016

Notable Operations Projects and Their Statuses Prepared by Chris Miller, Chief Operations Officer

City Online Video Provider Issue: Solved - Data fragments in the Granicus system caused by issues last month were reviewed by the manufacturer. The issues could not have been fixed by a user and Granicus cleaned them up.

Studio B Project: Relocation Probable - While we are still working with the installer on another camera control issue, the system is operable and being utilized by staff. The impending move of administrative offices to the first floor is likely to merge this technology into the main studio this December. At that point, we will begin training with the public and it will be available for use with the large green cyclorama.

Low-Power FM Radio Partnership with National Hispanic Media Coalition: Ongoing - I have met with the radio engineer to discuss the apparatus (two 2'x1' antennae and associated cabling) which will be installed on the roof. I am working with a City Planner and building management to ensure all procedures are followed and rights are obtained before proceeding.

Charter KPAS Outage 11/1: Solved - A video on the Charter KPAS feed was stuttering during a routine channel check. By the time I arrived at City Hall to investigate, the external hard drive the file was playing back from had ceased spinning. I replaced the hard drive case, which restored functionality. AT&T and online streams were unaffected.

AT&T/Streams Outage 11/3: Solved - After a power spike, one of our UPS battery backups entered an error state instead of coming back online. As all power was cut of to the our playback system, the channels were down on AT&T and the online streams for approximately 3 hours. We rerouted power from another UPS and restored the channels at 9:30am. We replaced the batteries inside the UPS and put the unit back into service a week later. The playout system at City Hall reacted normally so Charter was not affected.

City Council Chamber Meeting Management System Assisted Listening Issue 11/7: Ongoing - The audio distribution system output that feeds the assisted listening devices malfunctioned. We bypassed the port by connecting the assisted listening transmitter directly to an output from our audio board. DoIT has been contacted about seeking a permanent repair.

PCC-TV

Channel Manager's Report December 6, 2016

Recent Developments

- <u>PEG fund grant:</u> Paperwork has been filed to begin PCC's Request for Proposals process. Next steps: Funding stream finalized, PCC Board approval of bid request, RFP issued.
- <u>KPAS PSAs:</u> PCC-TV is currently airing identical video and still-frame imagery created by the City of Pasadena and the Pasadena Public Health Department designed to inform viewers of the dangers of menthol cigarettes, electronic vaping devices, and tobacco-flavored products. Airing as part of an effort to present a "unified front" against smoking in our community, and in concert with PCC's smokefree campus policy.
- <u>Music/Theatre Performance Rights:</u> Continuing conversations with faculty in music and other performing arts to understand hurdles to airing student performances on PCC-TV. Individual agreements are being managed between students and faculty ensemble directors, and composition/performance rights are another area of exploration. Hope to have even more of PCC's cultural life on display through PCAC channels.
- <u>Student internships:</u> Working with television/radio faculty to create an in-house internship program whereby students would gain basic skills through apprenticeships in PCC's marketing office and then go on to greater responsibility at PCC-TV. Program details continue to be nailed down; hope to have something in place by Spring or Summer terms.
- Programming update: A number of programs running in rotation. Beyond the
 regular governance meetings and other college events, an informative presentation
 by UCLA education professor Tyrone Howard on the state of equity in public
 education and the September Civil Engagement forum featuring presidents of five
 Pasadena educational institutions.
