KEY HIGHLIGHTS:

- George Falardeau finalized the candidates for PCAC's Citizens Advisory Committee. Worked on this endeavor with Phil Hopkins who will be presenting candidates for approval at tonight's meeting.
- Attended the SoCalGas Company's Community Advisory Council meeting at their headquarters in LA. This effort resulted in a \$500 donation to Pasadena Media.
- Attended the unveiling of the Jackie Robinson statue at the Rose Bowl. This event was covered by Pasadena Media and will air on KPAS at a later date.
- George Falardeau and Aaron Wheeler attended Councilmember Gene Masuda's District 4 meeting at the AGBU Vatche and Tamar Manoukian High School and Cultural Center. Presentation was well received.
- George Falardeau was named Director of the Pasadena Chamber of Commerce Foundation.
- Pasadena Media successfully completed two interview sessions with Mayor Terry Tornek for IMPACT Pasadena and former mayor Bill Bogaard for the New City Beat.
- Pasadena Media received a letter of appreciation from Councilmember and Vice Mayor John J. Kennedy thanking our team and myself for all the work we've done during District 3 Community meetings.

Operations Report - November 2017

Notable Operations Projects and Their Statuses - Prepared by Chris Miller, Chief Operations Officer

Fiber Installation: Testing Continues

We have utilized existing gear to bypass playout equipment at City Hall for both KPAS and Arroyo for the past six weeks using the City's Dept. of Information Technology temporary test switches on each end. We have purchased our own equipment to replace DoIT's. We are testing other delivery methods before purchasing the last round of equipment that will add PCC TV transmission and the ability to send live video from City Hall to Pasadena Media. When completed, we will keep the legacy equipment ready to use as backup for the primary system at Pasadena Media.

Charter Cable Issues: Ongoing

During October several issues with our equipment and Charter's channel signals caused us to accelerate our fiber testing timeline and begin troubleshooting with Charter technicians. The most notable of these issues were low and distorted audio signals on KPAS and Arroyo, as well as video with heavy interference. We have regularly adjusted our equipment during this process while keeping Charter informed. While Charter has not been as responsive as in the past, we continue to work with them and await a chance to perform a calibration of both their equipment and ours. In anticipation of this calibration, this week we replaced all of the cabling and modulators that interface with Charter equipment to ensure we are sending them the best signal possible. This has increased the quality of KPAS to pre-October levels while Arroyo quality remains sub-par. We will continue to work with Charter to maintain high quality on all channels.



Repeal Net Neutrality Protections

RECOMMENDATION:

It is recommended that the PCAC Board of Directors:

- 1. Find that the request for the action proposed herein is not a "project" as defined in the California Environmental Quality Act (CEQA), Public Resources Code Section 21065 and Section 15378(b)(2) of the State CEQA Guidelines and, as such, is not subject to environmental review.
- 2. Approve request that the Pasadena City Council's Legislative Policy Committee include in the City's 2018 Legislative Platform language that opposes any attempt to repeal existing Net Neutrality Protections; and supports national or local efforts that strengthen Net Neutrality.
- 3. Authorize the PCAC Executive Director to forward a letter pertaining to the Board's request to the Legislative Policy Committee to be considered at the Committee's Meeting on Dec. 12, 2017, and
- 4. Authorize the PCAC Executive Director to share the Board's request and letter with other access centers and organizations as appropriate.

BACKGROUND

The Pasadena Community Access Corporation (PCAC), also now doing business as Pasadena Media, is established by Chapter 2.155 of the Pasadena Municipal Code as one of the City's three operating companies and has been in operation for nearly 35 years.

Pursuant to the provisions of the Municipal Code, PCAC is the umbrella, non-profit agency that oversees the PEG (Public, Education and Government) cable TV access network of television stations and the local production studio facility serving Pasadena, including KPAS (City of Pasadena); Arroyo Channel (public access); PCC-TV (Pasadena City College) and KLRN-Pasadena (Pasadena Unified School District).

PCAC also serves as the City's officially designated front-line representative for all residents and businesses to help resolve consumer/customer concerns and complaints about their cable service, which is regularly bundled together with Internet access as one service by the local providers, primarily Charter and AT&T, and considered one bill for both Internet service and cable. PCAC's telephone number is required to be on Pasadena customers' bills for complaint resolution assistance.

In addition, as local cable access operations like PCAC have matured over the years, a significant portion of the video programming developed and freely distributed by PCAC to the public on behalf of the City is done so via the Internet through video streaming sites and social media platforms. This includes vital public information that furthers the goals of the City of Pasadena, contributes to citizen participation in government and offers transparency in the government decision-making processes and expenditures of public taxpayer monies. Examples of such programming includes City Council meetings on the City budget and contracts; emergency public information; public service announcements and information about programs, services and opportunities on other public meetings or events like the recent One Arroyo Day and the new Jackie Robinson statue at the Rose Bowl Stadium.

A similar scenario is directly applicable to the other organizations that use cable access channels in Pasadena as part of the local PEG network serving Pasadena, specifically the Arroyo Channel (public access); PCC-TV (Pasadena City College) and KLRN-Pasadena (Pasadena Unified School District).

All four entities—The City, PCAC, Pasadena City College and the Pasadena Unified School District—have a vested interest to ensure all of the public and businesses they serve have equal access to the Internet in the interests of free speech, government transparency, public education, economic growth, emergency public information and access to real information. PCAC, as the City's official representative for its citizens and businesses regarding access to cable/internet, is at the forefront of the issue of Net Neutrality locally.

NET NEUTRALITY

The basic premise of Net Neutrality is that everybody is in control of their own Internet and online experience. Net Neutrality's guiding principle is to preserves our right to communicate freely online.

When you go online, there is an expectation that you can be connected to whatever website you want. You expect that your cable or phone company—the Internet Service Provider (ISP)—does not have the right to interfere with your free speech rights and is connecting and displaying all of the websites, applications and content you choose.

Net Neutrality prohibits an ISP like AT&T, Charter, Comcast and Verizon from speeding up, slowing down or blocking any content, applications or websites you want to use. Without Net Neutrality, any ISP would be able to block content and speech without your knowledge; reject apps or websites that compete with their own offerings, and prioritize Web traffic by reserving the fastest loading speeds for the highest bidders and sticking everyone else with the slowest, or worse, blocking access. Just as your phone company cannot decide who you call and what you say on that call, Net Neutrality prevents an ISP from interfering with the content you view or post online.

After a decade-long battle over the future of the internet, the Federal Communications Commission (FCC) in 2015 adopted strong Net Neutrality rules based on Title II of the Communications Act, giving internet users the strongest protections possible, keeping the Internet free and open. Title II gives the FCC the authority it needs to ensure that companies like AT&T, Charter, Comcast and Verizon can't block, throttle or otherwise interfere with web traffic. Title II preserves the internet's level playing field, allowing people and businesses to share and access information of their choosing.

WHAT WOULD HAPPEN IN PASADENA IF NET NEUTRALITY WAS LOST?

The effects of any repeal of Net Neutrality would not just impact Pasadena alone. Pasadena's residents, business, the City itself and all educational institutions would potentially experience the same negative outcomes as others across the nation. Some of the impacts and changes that can be expected include:

- Increase consumers' costs paid for cable and Internet services; this would have a
 greater impact on low-income families or seniors on a fixed income
- Limit online content that is available at homes, businesses, schools and public libraries, sometimes without knowing that the content is being arbitrarily blocked, censored or limited.
- Allow greater misuse of "fake news" by entities willing to pay large sums of money to ISPs to push out their agenda, i.e., a "Pay for Play" regardless of the accuracy of the content
- Increased costs to the City's General Fund that is used to pay for the City's Internet access
- Limit the public's access to Pasadena government information, including City Council meetings, library information and emergency public information that is

- streamed online because an ISP would be able to hold back content asked for or content delivered by the City's stream if a business wanted to pay for more bandwidth, thereby potentially reducing content from others.
- Limit transparency and public participation for the City, Pasadena City College and Pasadena Unified School District regarding public meetings
- Stagnate growth of local start-up businesses. As noted in the New York Times, Net Neutrality currently helps start-up businesses' access to the Internet at a critical time when they cannot pay for "fast-line" access like big companies can, which will negatively impact a local start-up's ability to grow, and is in conflict with the City's Economic Strategic Plan to foster local high-tech start-ups. https://www.nytimes.com/2017/11/29/technology/internet-dying-repeal-net-neutrality.html

BOARD POLICY CONSIDERATION

Although PCAC is locally at the forefront of Net Neutrality issues in Pasadena for cable and Internet customers, the Board should know that the issue also has the potential to negatively impact more than 1.5 million people who each year visit or use the Pasadena Public Library system, in person or via the Internet. In 2016, more than 340,000 free Internet sessions were launched by patrons using the Pasadena Public Library resources. The Pasadena Public Library and members of the City's Library Commission also believe Net Neutrality rules should remain in place to ensure equal access to education and information, according to the Library Director.

In addition to protecting local consumers and businesses, as well as its own needs, the PCAC Board should also consider protecting the Public Library's Internet needs and those of local public and private educational institutions such as Pasadena City College, Caltech, Fuller Theological Seminary and the Pasadena Unified School District.

Many local governments and PEG cable access organizations similar to PCAC, as well as professional organizations such as the National League of Cities and the National Association of Telecommunications Officers and Advisors (NATOA) Board of Directors have adopted statements in favor of keeping Net Neutrality. NATOA, recently declared it to be "organization dedicated to promoting community interests in communications" and "has reinforced its long standing policy statement regarding the non-discriminatory access by all users to all forms of communications services."

NATOA's current policy states:

- NATOA supports the effective and efficient use of all communications technologies including voice, video, data, and information services over wired and wireless transmission technologies.
- Local governments support implementation of Federal, State and Local laws and rules that encourage open and interconnected services and technologies that are universally available to all citizens.

As such, it is well within the purview of the PCAC Board of Directors to approve a request to the City's Legislative Policy Committee that it include as part of the City's 2018 Legislative Platform opposition to efforts to repeal Net Neutrality and to support efforts to strengthen Net Neutrality protections.

ENVIRONMENTAL ANALYSIS:

The Policy Recommendation by the Pasadena Community Access Corp. (PCAC) is exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines. The request for the action proposed is not a "project" as defined in the California Environmental Quality Act (CEQA), Public Resources Code Section 21065 and Section 15378(b)(2) of the State CEQA Guidelines and, as such, is not subject to environmental review.

FISCAL IMPACT:

There is no negative fiscal impact as a result of this action, but support of Net Neutrality and opposition to its repeal can help prevent the City, the public, businesses, new startups, schools and other local government agencies from paying more for Internet services in the future.
