## **Operations Report - April 2018**

Notable Operations Projects and Their Statuses - Prepared by Chris Miller, Chief Operations Officer

## Fiber Installation / Charter Cable Issues: Ongoing

We have begun purchasing the last round of equipment. I have also commenced communicating with Charter about upgrading delivery of our channel signals. The main goal of the proposed upgrades are to produce consistent video and audio quality on the current channels. We are also requesting high definition channels.

## Main Playout System File Playback Issue: In Progress

The issue in which a service in one of the two playout servers crashed causing playback to stop on KPAS and PCC-TV has occurred twice since the instance on 3/30. While rebooting the system corrects the issue, we are working with the vendor who hasn't yet determined a permanent fix.

## **Editing Bay Issues: In Progress**

Recent updates to the Adobe Creative Suite have been producing various hardware and software compatibility issues that have impacted both staff and public editing projects. We are currently implementing several fixes to improve said issues, but this is unlikely to solve them permanently given the age of the systems. We will continue to research possible solutions.

## **City Council Chamber Monitor Issues: In Progress**

Two issues regarding monitors used for City Council Meetings arose this month. First, the monitor used to display open captions in the chamber for hearing impaired attendees was being used by public commenters to strategically place signage about their causes on camera behind speakers at the public podium. We are developing a method of displaying captions without program video. The second issue involves intermittent delivery of program video to the Chamber conference room where City staff waits. We are discussing options for this with DoIT (Department of Information Technology).

## NAB Trade Show 4/9-10: Attended

I recently attended the National Association of Broadcasters show in Las Vegas. This show features over 1700 vendors with a million square feet of exhibit space. I was able to talk to dozens of vendors, demo products first hand and attend several educational sessions. Among solutions I looked at were pedestals and heads, ip video delivery, cinema cameras and rigs, lenses, recording devices, closed captioning solutions, routers, switchers, SAN/NAS/cloud storage, mobile production systems and equipment cases.

#### FY 2019 Operating Budget Meeting with City Manager: Completed

George and I met with the City Manager and Finance Department personnel regarding the board-approved FY 2019 budget proposal on April 4. Finance personnel reached out to us the following week stating that "The City Manager has approved an additional \$20K in appropriations to PCAC for FY 2019. The direction is that the monies be used for merit/wage increases." George and I have instituted a COLA for all employees with the exception of the ED/CEO beginning July 1, pending budget approval by the City Council.


